## Instructions for preparing apparatus

These instructions detail the apparatus, reagents and specimens required by each candidate for each experiment in this paper. A summary of the questions that will be presented to the candidates is included, where appropriate, to allow the teacher to test the apparatus appropriately. **No access is permitted to the question paper in advance of the examination session.** 

It is assumed that the ordinary apparatus of a science laboratory will be available, including a supply of purified water (distilled or deionised).

If arrangements are made for different sessions for different groups of candidates, care must be taken to ensure that the different groups of candidates are effectively isolated so that **no information passes between them.** 

# All specimens should carry only the code letters and numbers as indicated and their identity should not be revealed to the candidates.

Supervisors should ensure that all specimens have the correct identity attached to the specimen and that these are **not** removed during the examination.

If a candidate breaks any of the apparatus, or loses any of the material supplied, the matter should be rectified and a note made in the Supervisor's Report.

Supervisors are advised to remind candidates that **all** substances in the examination should be treated with caution. Only those tests described in the Question Paper should be attempted. Pipette fillers and safety goggles should be used where necessary.

In accordance with COSHH (Control of Substances Hazardous to Health) Regulations, operative in the UK, a hazard appraisal of the examination has been carried out.

The following codes are used where relevant

<b>C</b> = corrosive substance	<b>F</b> = highly flammable substance
H = harmful or irritating substance	<b>O</b> = oxidising substance
T = toxic substance	<b>N</b> = harmful to the environment

The attention of Centres is drawn to any local regulations relating to safety, first-aid and disposal of chemicals.

'Hazard Data Sheets', relating to materials used in this examination, should be available from your chemical supplier.

The Supervisor should make sure the Supervisor's Report is fully completed and a copy is enclosed with each packet of scripts.

Centres are reminded that they are **not** permitted to open the question paper envelopes before the examination. Centres are also referred to the Handbook for Centres, and in particular Section 3.1.2(c)(i), Security of Question Papers and Examination Materials, as well as 3.3.11.1, Practical Examinations in Science Subjects.

## For question 1

Each candidate will need:

- (i) 30 cm<sup>3</sup> full fat milk (not skimmed or semi-skimmed), labelled **milk**
- (ii)  $25 \text{ cm}^3$  sodium carbonate solution, labelled **sodium carbonate**, concentration about  $0.05 \text{ mol}/\text{dm}^3$
- [N][H] (iii) phenolphthalein indicator, labelled phenolphthalein indicator, with dropping pipette
  - (iv) 5 cm<sup>3</sup> of a 5% lipase solution, labelled **unboiled lipase**, (freshly made up, stored in the refrigerator\*)
  - (v)  $5 \text{ cm}^3$  of a 5% boiled lipase solution, labelled **boiled lipase**
  - (vi) 2 large, hard glass, test-tubes (size 150 x 25 mm) labelled with a permanent marker pen, A and B
  - (vii) 1 test-tube rack or other means of holding tubes
  - (viii) 500 cm<sup>3</sup> beaker suitable for use as a water bath
  - (ix) a thermometer, range 0 °C to 100 °C with 1 °C divisions
  - (x) access to hot and cold water to make and maintain a water bath temperature of between  $35\,^\circ\text{C}$  and  $40\,^\circ\text{C}$
  - (xi) stopclock or timer with a seconds hand
  - (xii) 2 x 1 cm<sup>3</sup> syringes or 5 cm<sup>3</sup> syringes, and the means to wash them out (needles are **NOT** required and should **NOT** be given to candidates)
  - (xiii)  $2 \times 10 \text{ cm}^3$  measuring cylinders
  - (xiv) 1 test-tube (size 125 x 15 mm), labelled C with a permanent marker pen
- [H] (xv) about 10 cm<sup>3</sup> of biuret solution, labelled **biuret solution** 
  - (xvi) teat pipette or dropper.

\*Centres should make up the lipase solution no more than 24 hours in advance and store it in a refrigerator at 4 °C.


# For question 2

Each candidate will need:

- (i) access to a balance accurate to at least 0.1 g
- (ii) 250 cm<sup>3</sup> measuring cylinder
- (iii) a piece of plastic pipe/tubing of approximate length 75 mm and external diameter allowing it to fit comfortably into a 250 cm<sup>3</sup> measuring cylinder; the wall thickness of the pipe / tubing should be at least 2 mm and the pipe/tubing **must** float in water

Note: a 20 cm<sup>3</sup> plastic syringe barrel with the ends cut off could be used.

- (iv) rule at least 15 cm long and with 1 mm divisions
- (v) a metal weight (which could be a slotted weight) that must be capable of being attached to the pipe and then causing the pipe to sink



- (vi) a piece of thread at least 60 cm long
- (vii) paper towels.

# For question 3

Each candidate will need:

- (i) a stopclock or timer with a seconds hand
- (ii) a thermometer range 0 °C to 100 °C with 1 °C divisions
- (iii) a transparent (see-through) plastic cup
- (iv) 3g of fresh zinc powder labelled A
- (v) a  $25 \text{ cm}^3$  measuring cylinder
- [H] (vi)  $30 \text{ cm}^3$  of copper sulfate solution, CuSO<sub>4</sub>.5H<sub>2</sub>O, concentration 200 g dm<sup>-3</sup>, labelled **B** 
  - (vii) a stirring rod.

Note that the heavy metals in this experiment should be disposed of in a way that does not harm the environment.

Spare materials and equipment should be available and can be provided without penalty. **Candidates should be made aware of this.** 

#### Information required from the Supervisor:

The Supervisor is asked to carry out the experiments and to enter the results on a spare copy of the examination paper, clearly marked 'Supervisor's Results' and showing the Centre number. This should be done, out of sight of the candidates, using the same solutions, reagents, specimens and apparatus as the candidates.

A copy of the 'Supervisor's Results' should be returned with each packet of scripts. Failure to do so may cause the candidates to be penalised.
